

Policy on use of cookies on the website <http://digitalpark.sk/sk/uvod>

This policy on use of cookies applies to the website <http://digitalpark.sk/sk/uvod> operated by the company Penta Real Estate, s.r.o., having its registered office at Digital Park II, Einsteinova 25, 851 01 Bratislava, Identification No.: 51 284 502 (hereinafter referred to as the “cookies”).

What are cookies?

Cookies are small text files saved by a browser in the visitor's computer or other device, such as a mobile phone or tablet when visiting a website. The cookies enable the website to identify the user's device and to remember certain information about your interactions during your connection. The cookies remember the type of the user's browser or chosen settings that will remain as your default settings in case of a repeated visit of the website, thus improving your user experience.

What we use the cookies for?

We use the cookies especially in order to improve our services and your experience when viewing this website. We pursue these purposes in particular with the help of collection of aggregate statistical data about the number of visitors, automatic selection of a language of the website and collection of data about the use of this website.

The cookies we use do not damage your computer or other device through which you view our website and they cannot be used for the collection of your personal data.

What type of cookies we use?

We use on our website the following cookies:

- Necessary cookies: These cookies are required for the operation of our website. These include cookies that enable you to sign in to secure sections of our website.
- Performance cookies: These cookies enable us to analyse in which way you interact with our website. We may use this information to improve and simplify the usability of our website. Data collected by these cookies are aggregated and anonymous.
- Functional cookies: These cookies remember your choices in order to improve your user experience. In this way they enable our website to adapt the content to you or to remember your chosen preferences. Data collected by these cookies do not personally identify you.

Cookies of third parties

For some functions of our website we use also third parties as suppliers. For example, in case of videos embedded from the YouTube service or a link to this service or to a social network, such as Facebook, Instagram, Twitter, doubleclick.net and google.com etc. These videos or links (any other content from third party suppliers) may contain cookies of these third parties,

which they can use in some instances for their own purposes. For this reason, you should read the information about the use of such cookies in a policy on use of cookies of the respective third party.

How can I control or delete the cookies?

Most of the browsers accepts the cookies automatically. If you do not want to use the cookies, you must actively delete or block them. If you reject the use of the cookies, you will still be able to visit our website, however, some functions may not work correctly.
